
Application of David S. and Martha Stracener Dantzig, pursuant to 11 DCMR § 3104.1, for a special exception to allow an addition to a one-family semi-detached dwelling under section 223, not meeting requirements for lot occupancy (section 403), rear yard (section 404) and enlargement of a nonconforming structure (subsection 2001.3) in the R-4 District at premises 213 11th Street, S.E. (Square 969, Lots 804 and 805)
