**Application of The Holladay Corporation**, pursuant to 11 DCMR §§ 3104 1 and 3103 2, for variances from the rear yard (§774) and loading requirements (§2201), and special exception approval pursuant to §411 11 for roof structures not meeting the single enclosure and uniform height requirements and pursuant to §1330 1(c) for construction on a lot greater than 12,000 square feet, to construct new residential units in the GA/C-2-A Zone District at 713-735 Lamont Street, N W (Square 2893, Lots 875 and 879)
