Application of DAZ LLC, pursuant to 11 DCMR § 3103.2, for a variance from the minimum lot area requirements under § 401.3, to allow the conversion of an existing single family dwelling to a three unit apartment house in the R-4 District at premises 24 Rhode Island Avenue, N.E. (Square 3508, Lot 16).
