Application of Ingleside Presbyterian Retirement Community, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a variance from the minimum width requirements under § 401.3, and special exceptions from the community residence facility requirements under § 218, and the health care facility requirements under § 219, to allow an addition and increase in residents at an existing retirement community in the R-1-A District at premises 3050 Military Road, N W and 5314 29th Street, N W (Square 2287, Lots 802, 804, 809, 813, and Square 2290, Lot 30)
