Application of Thomas Reed, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot area requirements under § 401.3, the lot occupancy requirements under § 403.2, the court width requirements under § 406.1, and the nonconforming structure requirements under § 2001.3, to allow the construction of a second story addition to the rear portion of an existing single-family dwelling in the R-4 District at premises 131 Kentucky Avenue, S.E. (Square 1014, Lot 24).
