Application of 49th Street Developer LLC, pursuant to 11 DCMR § 3104.1, for a special exception from the new residential developments requirements under § 353, to construct a new affordable multi-family residential development for seniors and 21 affordable single-family dwellings in the R-5-A District on undeveloped land at the intersection of East Capitol Street, S E and 47th Street, S E (Square 5348, Lots 1-8)

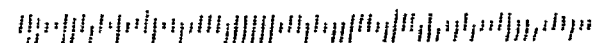

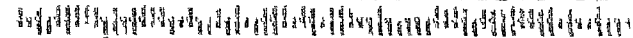
