Application of Timothy and Erin Barley, pursuant to 11 DCMR § 3104.1, for a special exception to allow a two story rear garage addition to a flat (two-family dwelling) under section 223, not meeting the rear yard (section 404), requirements in the R-4 District at premises 1229 F Street, N.E. (Square 1007, Lot 805).

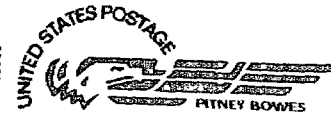
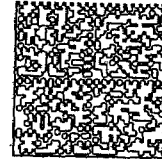
