Application of Jeffrey Blend, pursuant to 11 DCMR § 3103.2, for variances from the rear yard requirements under § 404.1, and the accessory building requirements under § 2500, to allow the addition of a sunroom to the rear of an existing one-family dwelling in the R-1-B District at premises 1211 Kalmia Road N.W. (Square 2959, Lot 1).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 4A. 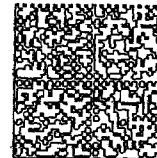

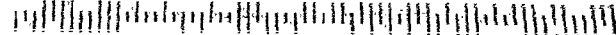

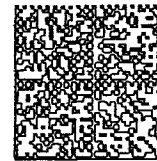
