Application of Alexandra Freidberg, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot occupancy requirements under § 403.2, the minimum court width requirements under § 406.1, and the nonconforming structure requirements under § 2001.3, to allow the enlargement of existing attic space into a full third story in the R-4 District at premises 72 Seaton Place N.W. (Square 3106, Lot 96).

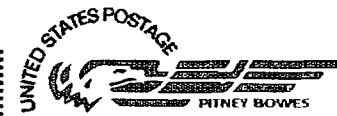
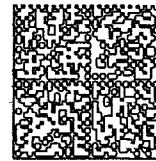
