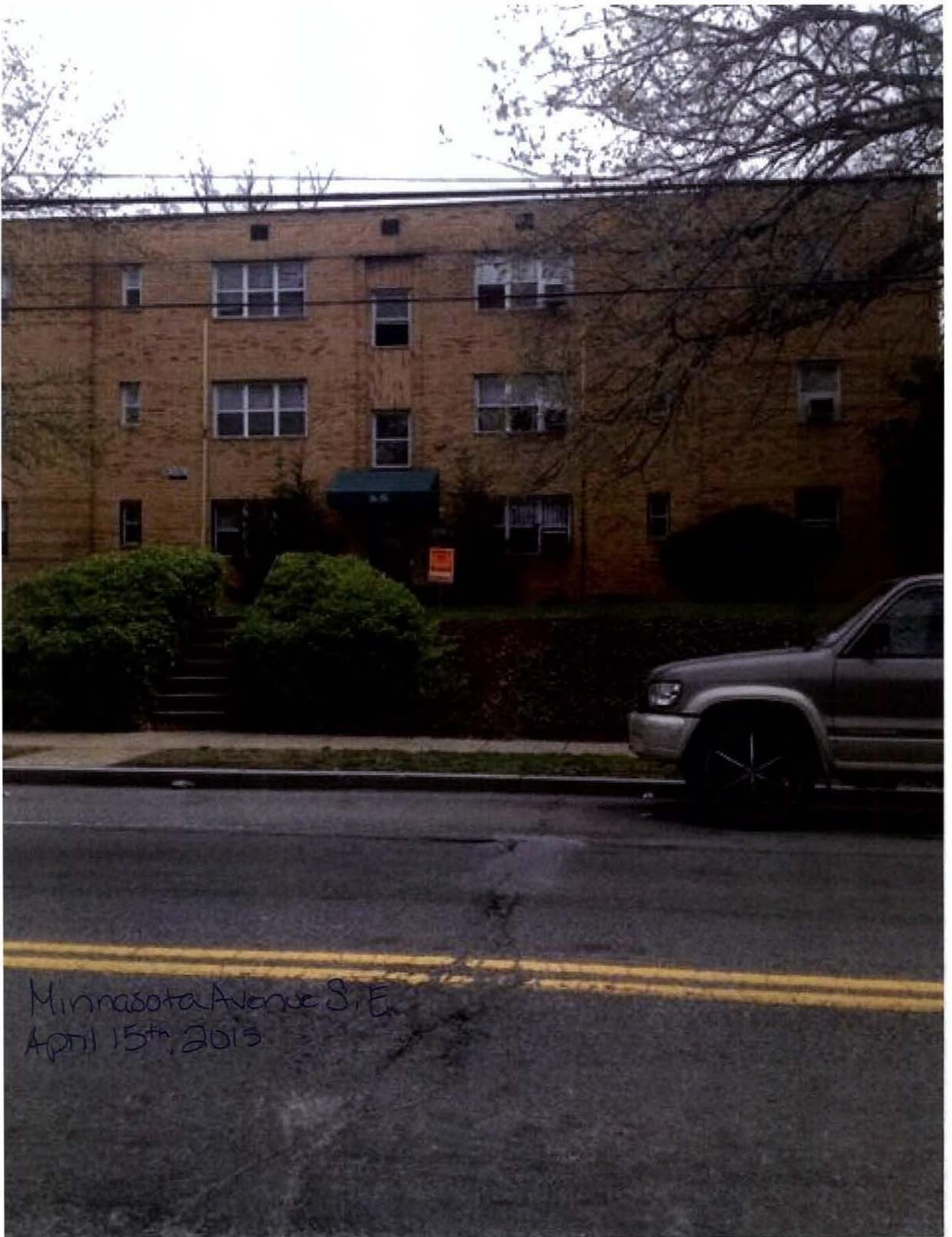


B Street SE.  
April 15 2015





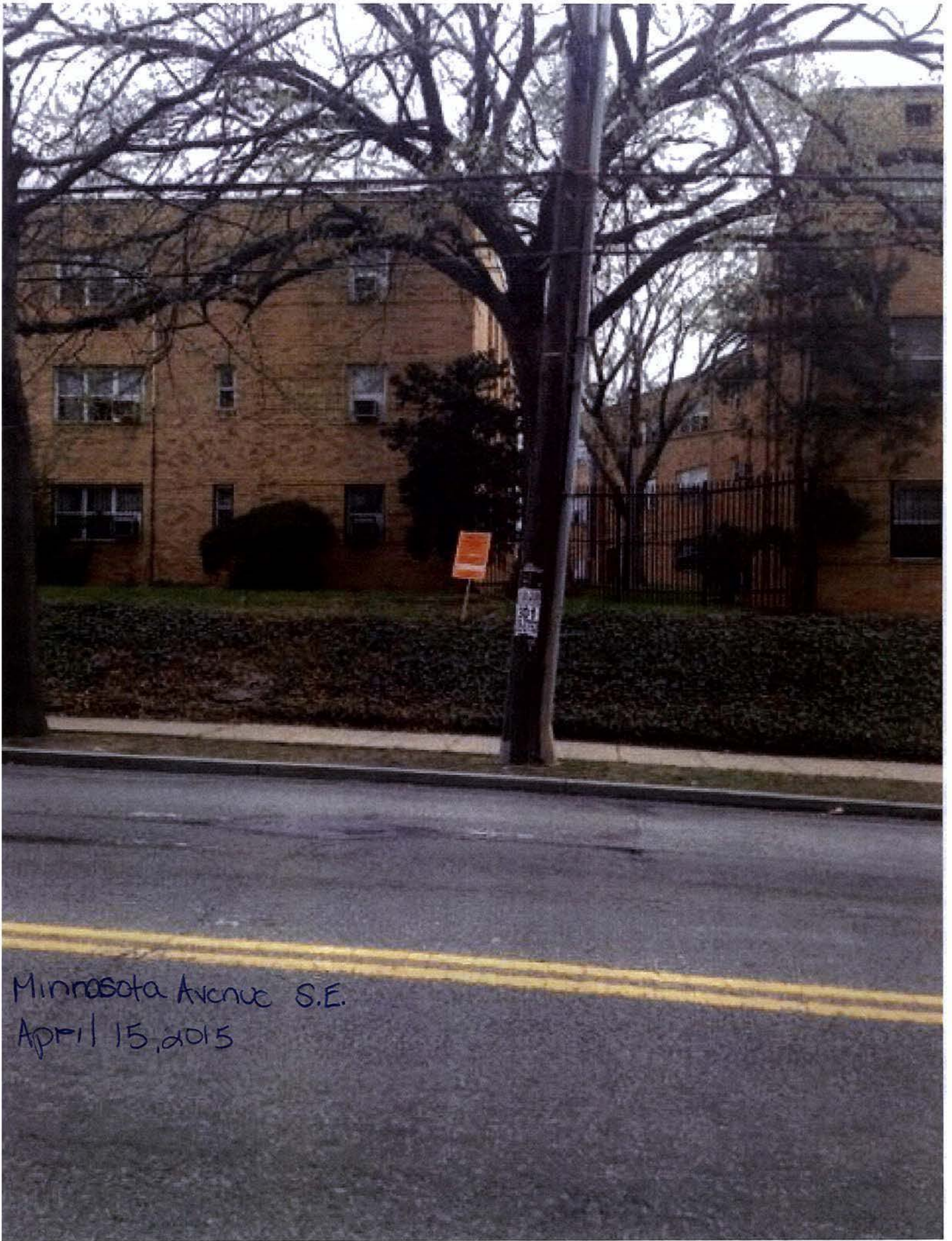
B Street Parking Lot

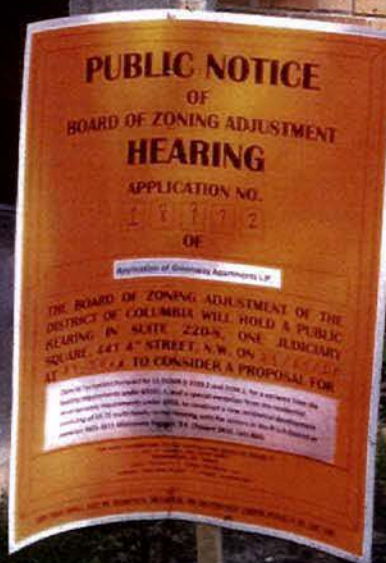

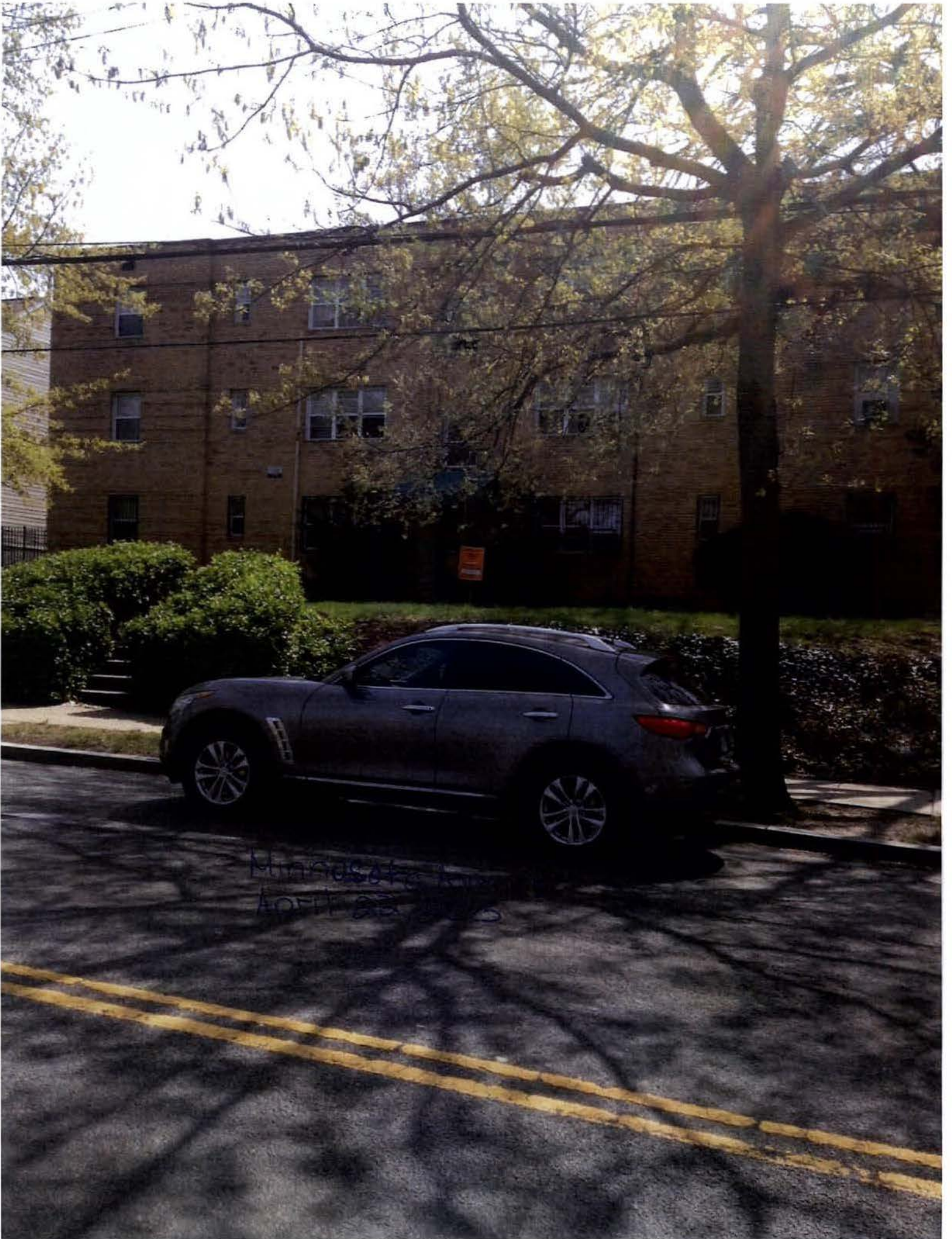




B Street Parking Lot

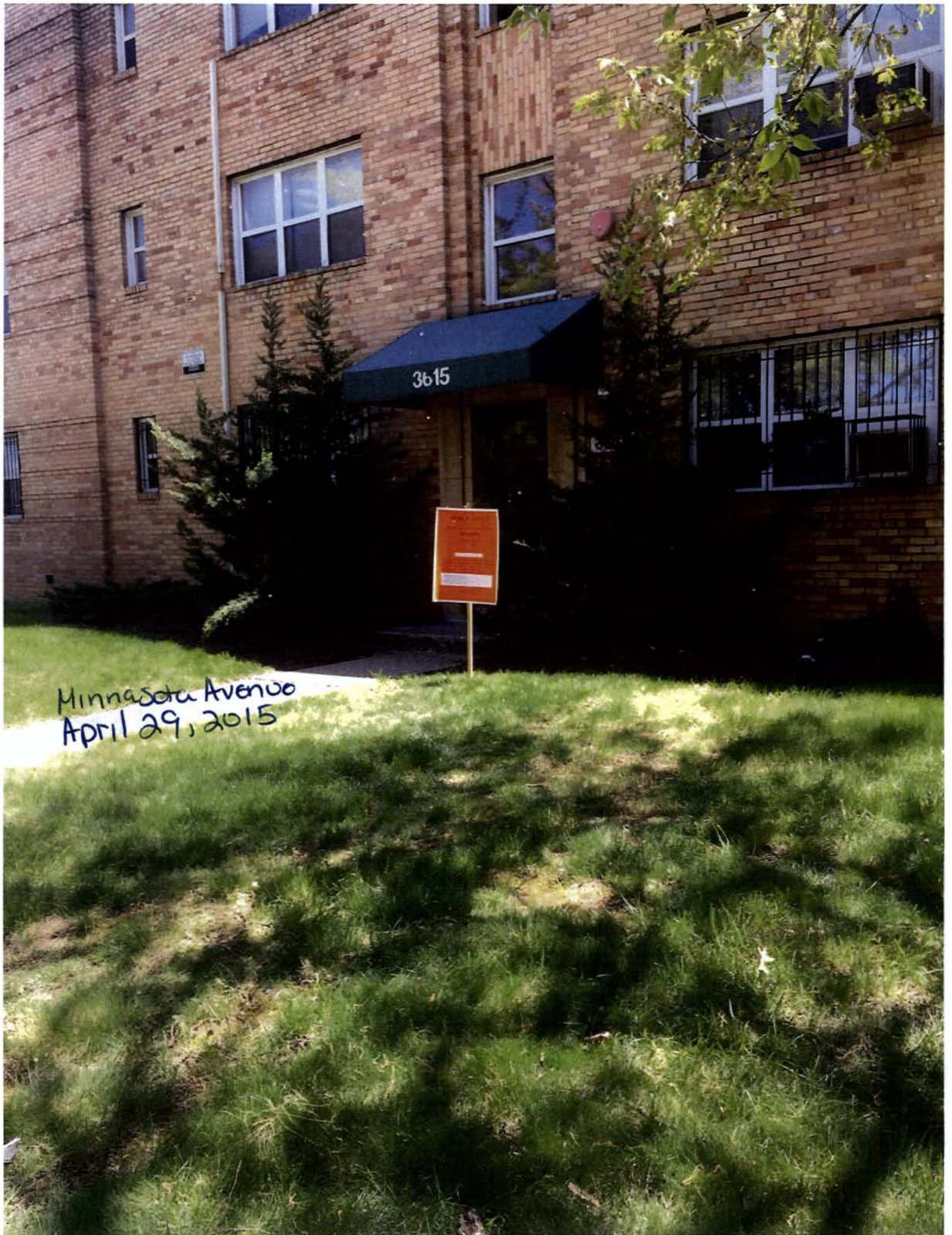

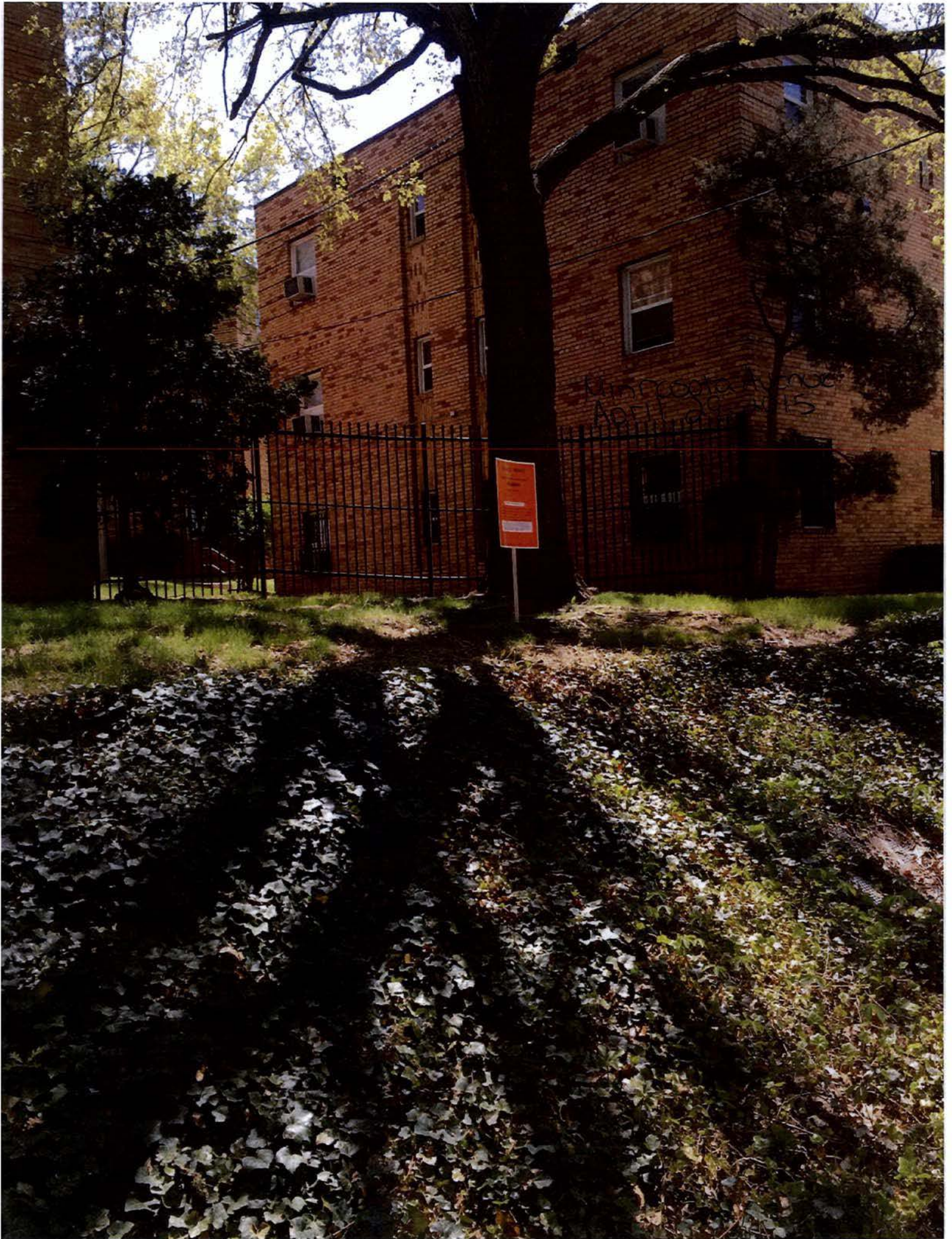
