

Dear BZA Chairs,

We are writing this letter to request that our presentation date, currently scheduled for April 5th, be postponed to April 12th. We are requesting this postponement so that our BZA hearing is held after our April 6th ANC meeting. Our ANC meeting was rescheduled because we were unable to obtain a signed revised ZA memorandum by February 24th, the due date for our the ANC presentation material. To date, we still do not have the signed revised ZA memorandum due to several illnesses of zoning staff.

We are making progress. We have the official drawings, specifics on the existing shed, layouts showing our use and a draft of the memorandum. We were waiting for the official memorandum before submitting these items to IZIS. However, given the delay, we will submit them with the draft memorandum. Below is a timeline of our efforts.

To be clear, Phong and I are requesting the March 3rd meeting postponement in order to give all parties involved adequate time to review and prepare. As it stands today, we will not have a final signed memorandum from DCRA/Zoning to present at the ANC (We will likely have a draft). We would like to have the final memorandum and our near-final plans with options for discussion with Mr. Becka first and then other neighbors.
