Application of Chris Lobb and Paola Barbara, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot occupancy requirements under § 403.2, and the rear yard requirements under § 404.1, to allow the construction of a two-story rear addition with accessory apartment connected to the dwelling by a covered walkway in the R-4 District at premises 148 11th Street S.E. (Square 989, Lot 26).

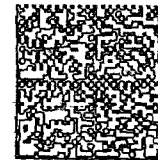

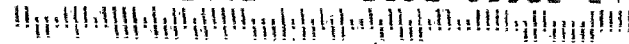

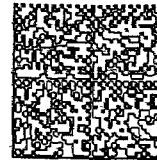
