Application of Rainbow Child Development Center, pursuant to 11 DCMR § 3104.1, for a special exception from the child development center requirements under § 205, to expand a child development center with 42 children and nine staff to a child development center with 72 children and 12 staff in the R-2 District at premises 505 57th Street N.E. (Square 5227, Lots 3 and 4).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 7C.
