Application of Marie Pollard, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot occupancy requirements under § 403.2, and the court width requirements under § 406.1, to construct a rear one-story addition to an existing two-story, one-family dwelling in the R-5-B District at premises 2216 12th Street N.W. (Square 271, Lot 195).

This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 1B.
