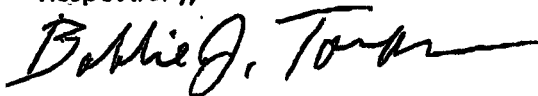
Dear Chairperson Jordon and Members of the Board:

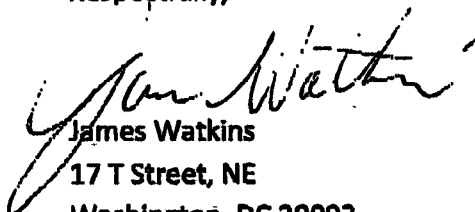
