Application of Better Living Development, LLC, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot occupancy requirements under § 403.2, and the non-conforming structure requirements under § 2001.3, to construct a third-story addition to an existing two-story flat in the R-4 District at premises 1551 3rd Street N W (Square 552, Lot 60).
