Notice is hereby given that the Board of Zoning Adjustment will hold a public hearing at 441 4th Street, N W , Suite 220 South, Washington, D.C., 20001 on Tuesday, June 23, 2015, on the following application.

Application of Better Living Development, LLC, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the lot occupancy requirements under § 403.2, and the non-conforming structure requirements under § 2001.3, to construct a third-story addition to an existing two-story flat in the R-4 District at premises 1551 3rd Street N.W. (Square 552, Lot 60).

Persons seeking party status shall file with the Board, not less than 14 days prior to the date set for the hearing, a Form 140 – Party Status Request form, a copy of which may be downloaded from the Office of Zoning's website at: <http://dcoz.dc.gov/services/app.shtm>. This form may also be obtained from the Office of Zoning at the address stated. This application is located within the boundaries of Advisory Neighborhood Commission 5E. 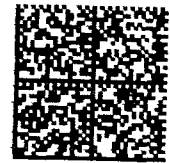

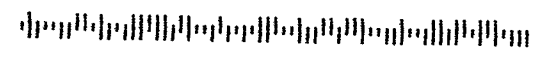
