Application of Jemal's Bulldog L.L.C., pursuant to 11 DCMR §§ 3103.2 and 3104.1, for variances from the court requirements under § 776, the off-street parking requirements under § 2101.1, and the loading requirements under § 2201.1, and a special exception from the rear yard requirements under § 774, to construct a new 13-story hotel building with cellar in the DD/C-3-C District at premises 1011 K Street N.W. (Square 342, Lots 4, 5, 53, and 809).
