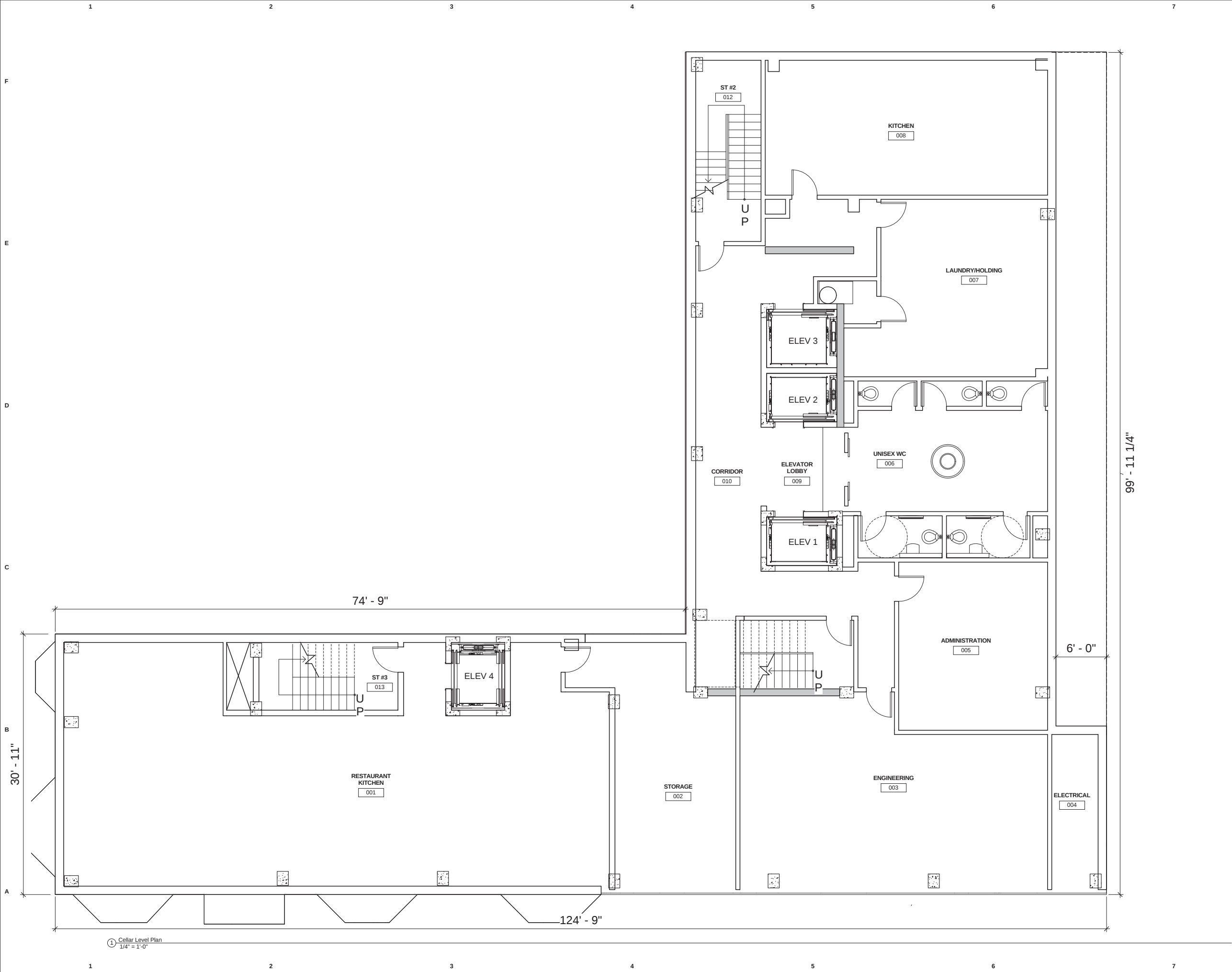

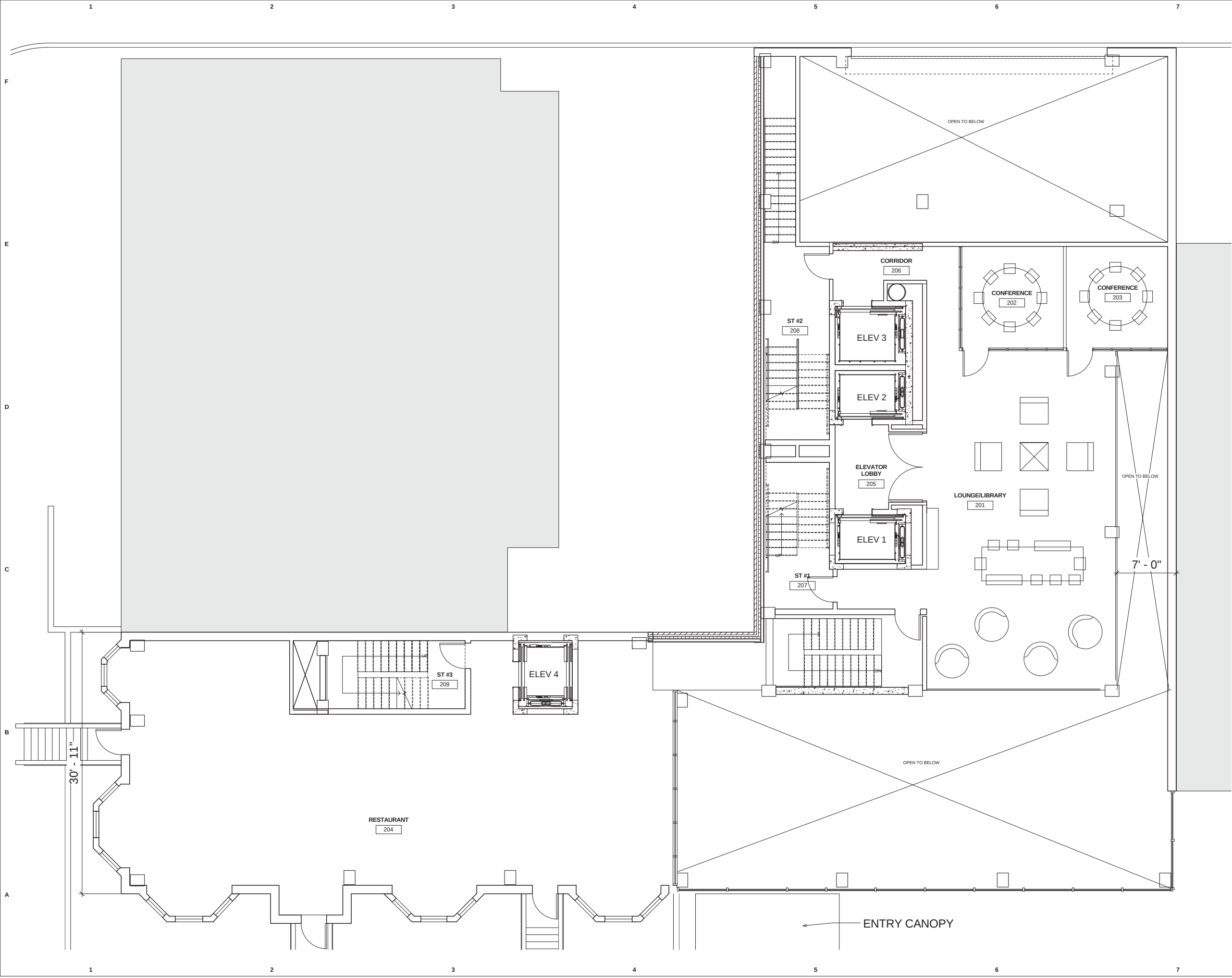
GROUND LEVEL

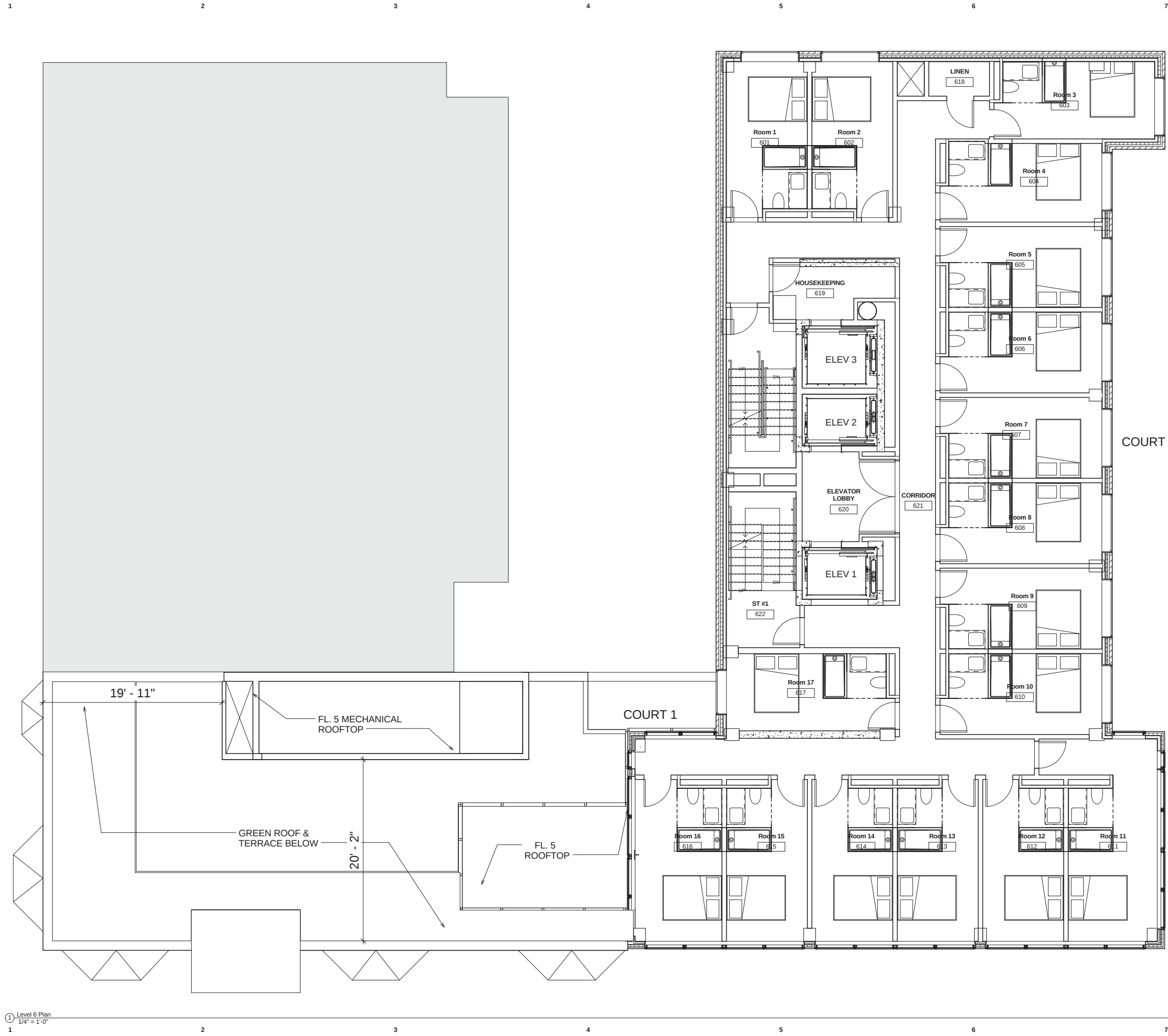

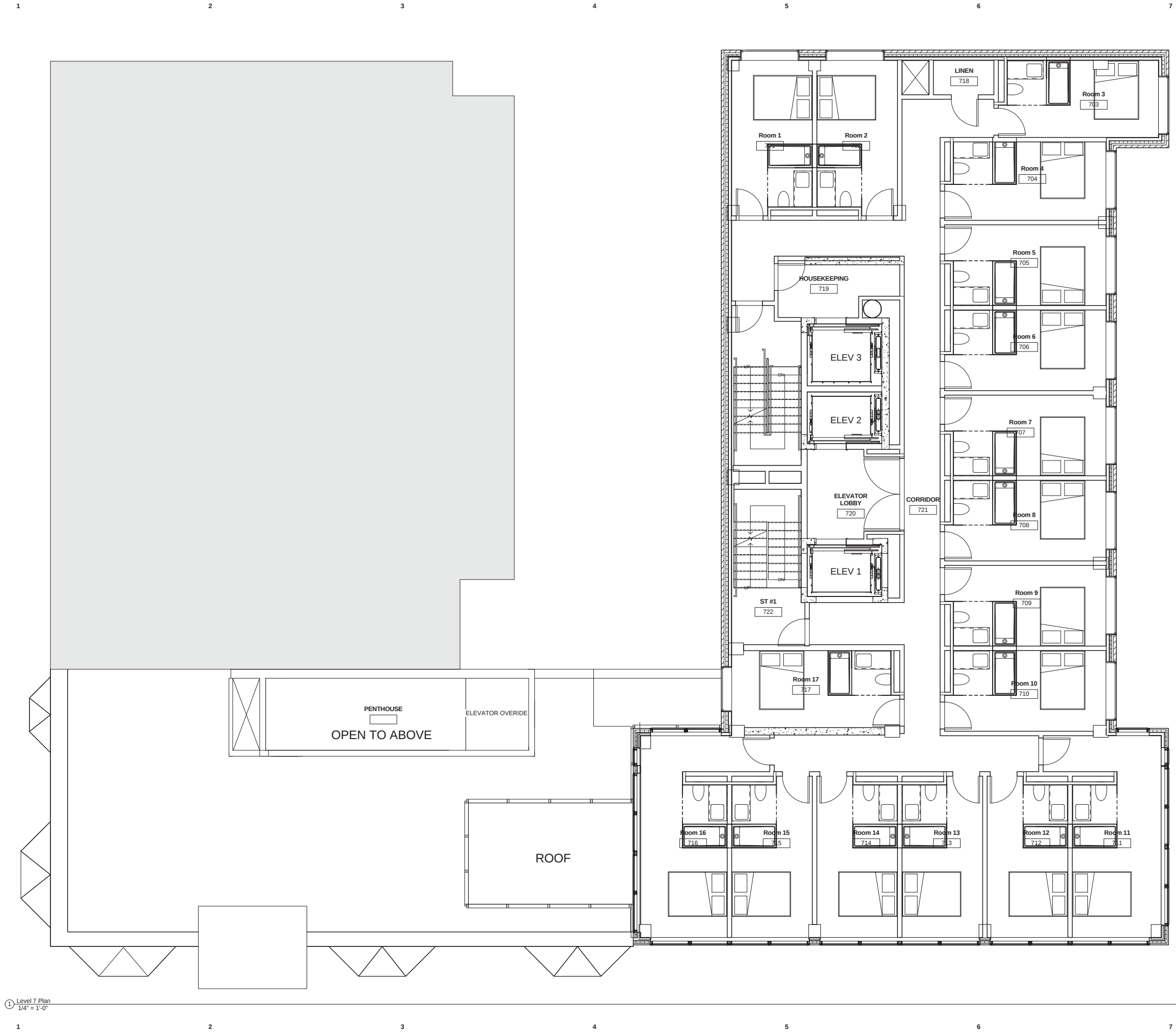

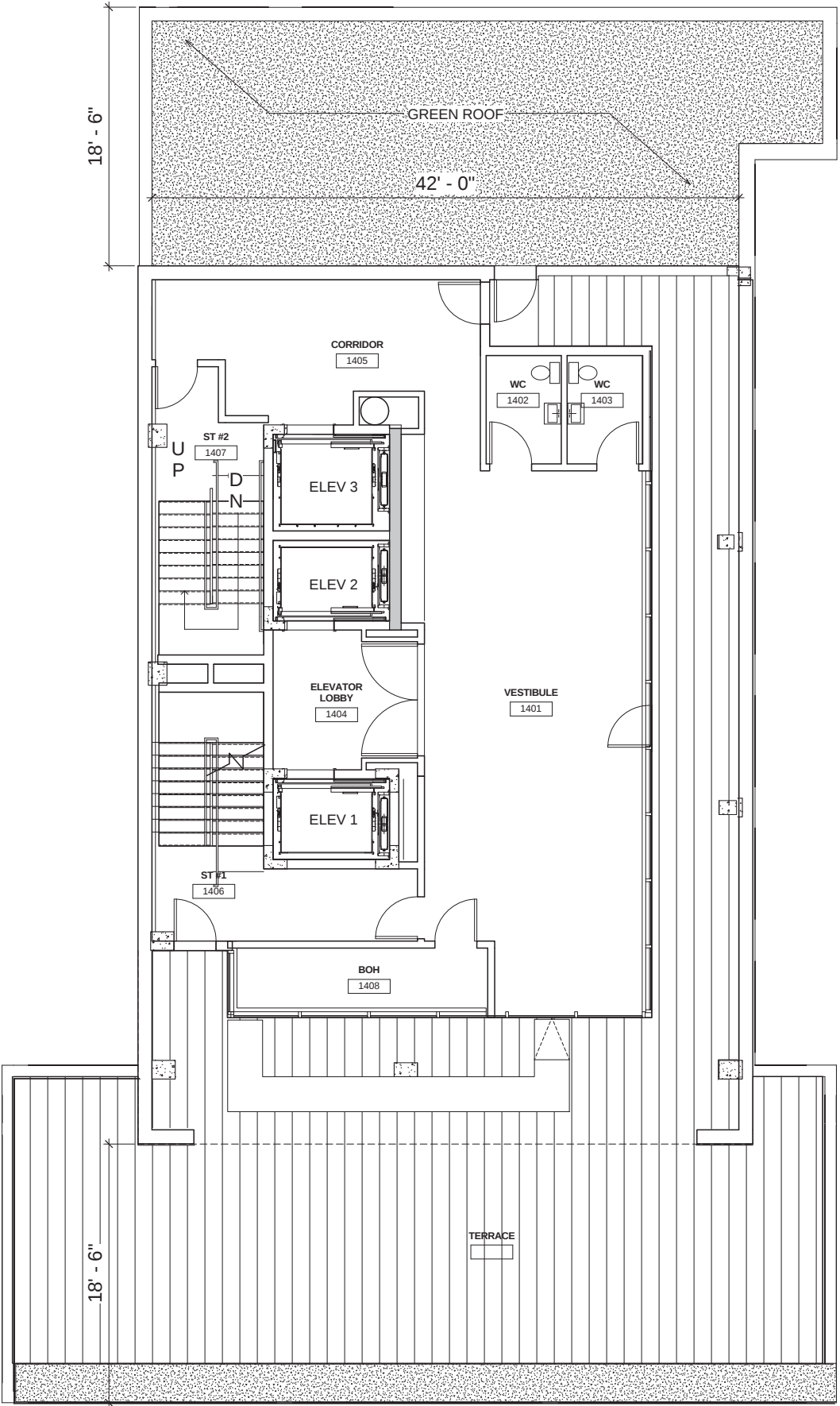
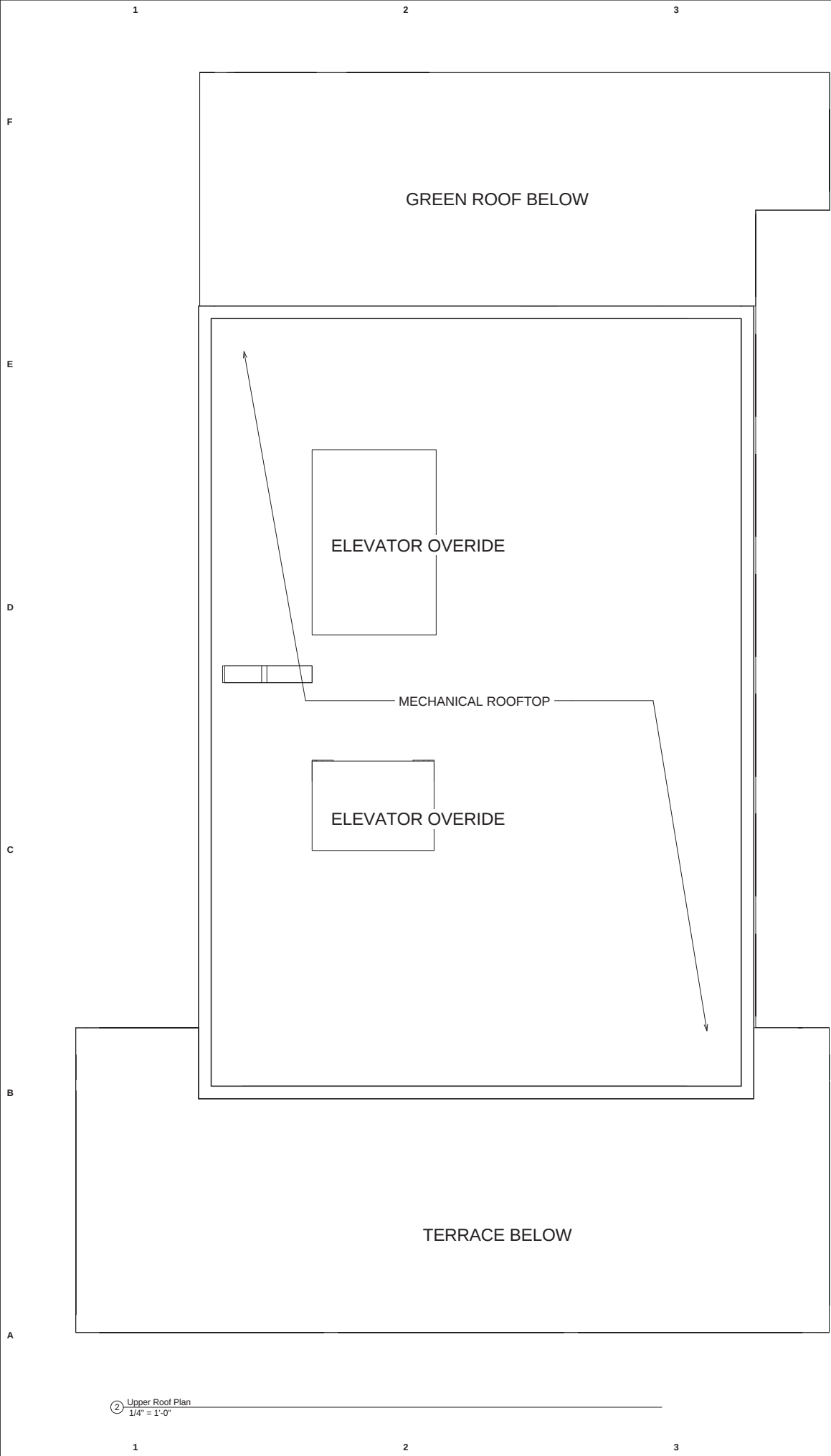
LEVELS 8-13 TYPICAL
