Application of Wiley Chambers, pursuant to 11 DCMR § 3104.1 for a special exception under § 223, not meeting the floor area requirements under § 402, to construct a balcony with staircase to an existing one-family dwelling in the FB/R-3 District at premises 2536 Queen Annes Lane N W (Square 16, Lot 91)

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:

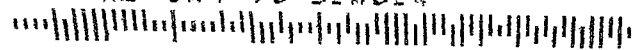
