Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, September 29, 2015 at 9:30 am**, at the Jerry R Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N W , Suite 220 South, Washington, D C., 20001, concerning the following application

Application of Michelle Munn, pursuant to 11 DCMR § 3104.1, for a special exception under § 223, not meeting the lot occupancy requirements under § 403, the rear yard requirements under § 404, and the side yard requirements under § 405, to allow the enclosure of an existing back porch, and construction of a new one-story rear addition to an existing one-family dwelling in the R-5-B District at premises 2118 2nd Street N W (Square 3070, Lot 67).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

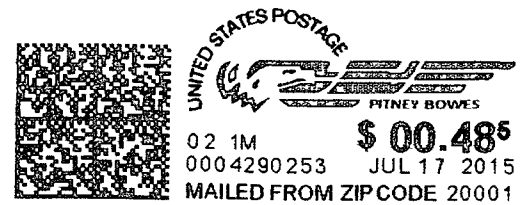

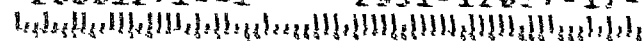
