Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, October 6, 2015 at 9:30 am**, at the Jerrily R Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N W , Suite 220 South, Washington, D C., 20001, concerning the following application

Application of 2002 11th Street LLC and Industrial Bank, pursuant to 11 DCMR § 3103 2, for variances from the public space at ground level requirements under § 633, the rear yard requirements under § 636 3, and the off-street parking requirements under § 2101 1, to allow the construction of a new mixed-use building with 33 residential units and ground floor retail in the CR/ARTS District at premises 2000-2002 11th Street N W (Square 304, Lots 27, 30, and 31)

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records
