Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, October 20, 2015 at 9:30 am**, at the Jerrily R Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N W , Suite 220 South, Washington, D C , 20001, concerning the following application

**Application of Simone Management, LLC**, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for variances from the off-street parking requirements under § 2101.1, and the parking access requirements under § 2117.5, and a special exception from the new residential developments requirements under § 353.1, to construct a new four-unit apartment house in the R-5-A District at premises 2205 16th Street S E (Square 5795, Lot 27)

**WHY YOU ARE RECEIVING THIS NOTICE**

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

**HOW TO FAMILIARIZE YOURSELF WITH THE CASE**
