Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, December 1, 2015 at 9:30 am**, at the Jerry R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N W, Suite 220 South, Washington, D C, 20001, concerning the following application

Application of Timothy Turnham, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for a variance from the lot occupancy requirements under § 403.2, and a special exception under § 223, not meeting the rear yard requirements under § 404, the court width requirements under § 406, and the nonconforming structure requirements under § 2001.3, and a special exception from the alley setback requirements under § 2300.2(b), to allow the construction of a one-story rear garage and deck addition to an existing one-family dwelling in the R-4 District at premises 1252 Columbia Road N W (Square 2583, Lot 70)

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

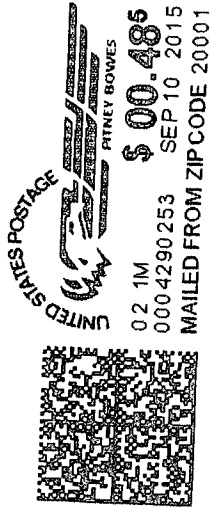
