Notice is hereby given that the Board of Zoning Adjustment (BZA) will hold a public hearing on **Tuesday, October 20, 2015 at 9:30 am**, at the Jerry R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N W, Suite 220 South, Washington, D C, 20001, concerning the following application

Application of the Embassy of the Russian Federation, pursuant to 11 DCMR § 1002 of the Foreign Missions Act, to allow the construction of a security fence at an existing embassy in the R-5-D District at premises 2001 Connecticut Avenue N W (Square 2536, Lot 308)

WHY YOU ARE RECEIVING THIS NOTICE

The Office of Foreign Missions of the United States Department of State has directed a chancery of a Foreign Mission to obtain BZA zoning relief for a project or use that is not provided as a matter of right for the zoning district. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

Please note that party status is not permitted in FMBZA cases.

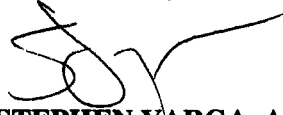
