

Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Tuesday, January 12, 2016 at 9:30 am</u>, at the Jerrily R Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, NW, Suite 220 South, Washington, DC, 20001, concerning the following application

Application of 3317 16th Street LLC, pursuant to 11 DCMR §§ 3103 2 and 3104 1, for variances from the off-street parking requirements under § 2101 1, the parking aisle width requirements under § 2117 5, and the loading berth requirements under § 2201 1, and a special exception from the HS Overlay requirements under § 1320 4(f), to convert a vacant church into a new four-story, mixed-use commercial and residential building in the HS-A/C-2-A District at premises 1301 H Street N E (Square 1027, Lot 156)

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records

HOW TO FAMILIARIZE YOURSELF WITH THE CASE
