We are homeowners looking to replace the existing rear addition on our house at 916 K st. NE. We are seeking special exceptions to 11-403, lot occupancy, and 11-404, rear-yard setback. The proposed addition exceeds the maximum lot occupancy of 60% in an R-4 zone. The current lot occupancy is 70%; the proposed lot occupancy is 68%. The proposed addition does not meet the minimum rear-yard setback of 20' in an R-4 zone. The current average rear-yard setback is 16'-10"; the proposed average rear-yard setback is 17'-9"
