Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of MR 608 T Contract LLC, et al., pursuant to 11 DCMR § 3103.2, for variances from the loading requirements under § 2201, and the height requirements under § 2604.2, to permit the construction of a seven-story mixed-use building in the ARTS/C-2-B District at premises 608, 610, 614, and 618 T Street, N.W. (Square 441, Lots 32, 33, 35, and 852).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
