Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, March 22, 2016 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 5Design Development LLC, pursuant to 11 DCMR § 3103.2, for variances from the floor area ratio requirements under § 402.4, and the nonconforming structure requirements under § 2001.3, to allow the construction of a third story onto an existing one-family dwelling in the R-5-B District at premises 2233 10th Street N.W. (Square 357, Lot 90).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

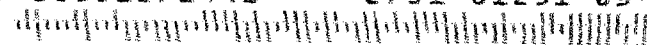

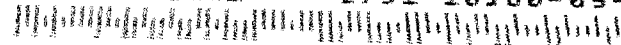

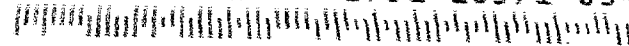
