Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Tuesday, May 10, 2016 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 1612 Seventh Street NW LP, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for variances from the lot occupancy requirements under § 772.1, and the rear yard requirements under § 774.1, and special exceptions from the off-street parking requirements under § 2101.1, and the historic structure parking requirements under § 2120.6, to allow the rehabilitation of and addition to a contributing historic structure for conversion to a mixed-use building with first and second floor retail uses, and eight residential units in the C-2-A District at premises 1612-1616 7th Street N.W. (Square 420, Lot 38).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:

- Visit the Office of Zoning (OZ) website at www.dcoz.dc.gov
- Under “Featured Services”, click on “Case Records”.
- Enter the BZA application number indicated above and click “Go”.
