An Applicant within the boundaries of your ANC area is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district.

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Tuesday, June 28, 2016 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 5th Street Partners LLC, on behalf of the District of Columbia, pursuant to 11 DCMR §§ 3103.2 and 3104.1, for variances from the height requirements under § 770.1, the FAR requirements under § 771.2, and the non-conforming structure requirements under § 2001.3, and a special exception from the community-based residential facilities requirements under § 732.1, to establish a short-term family housing facility in the C-2-A District at premises 5505 5th Street N.W. (Square 3260, Lot 54).

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

- This list comprises the full record in the case. Simply click "View" on any document you wish to see, and it will open a PDF document in a separate window.

HOW TO PARTICIPATE IN THE CASE

As described in the Zoning Regulations of the District of Columbia (Regulations), the affected ANC is an automatic party to the case and the Board gives "great weight" to its written report.
