Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, December 14, 2016 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following appeal:

Appeal of Dupont Circle Citizens Association, pursuant to 11 DCMR §§ 3100 and 3101, from a July 18, 2016 decision by the Zoning Administrator, Department of Consumer and Regulatory Affairs, to issue Building Permit No. B1603105, for the conversion of one-family dwelling into a four-unit apartment house in the R-5-B District at premises 1514 Q Street N.W. (Square 194, Lot 27).


