On Tuesday, January 17, 2017, the Advisory Neighborhood Commission 5E, at its duly noticed public monthly meeting, held at the Friendship-Armstrong Public Charter School, 1400 First Street, NW, Washington, DC, 20001, voted to support BZA Application #19421 for a special exception to establish a two unit residential dwelling at 18 T Street, NE, (Square 3509S, Lot 43).

Proper notice was given. Seven calendar days prior to the ANC 5E public monthly meeting, the agenda is posted on the ANC 5E website and all the local listservs and blogs. Each commissioner posts the agenda in four conspicuous places throughout their respective Single Member Districts.
