Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Wednesday, March 15, 2017 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of 1827 Wiltberger LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, and Subtitle K § 805.5, for a special exception under the rear yard requirements of Subtitle K § 805.1, to permit the conversion of, and addition to, an existing historic building into a mixed-use retail, office, and residential building in the ARTS-2 Zone at premises 1827 Wiltberger Street N.W. (Square 441, Lots 849 and 853).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:
