Dear Chairperson Hill,

Please accept the enclosed petition in support of the city's proposal to build Short Term Family Housing at 3320 Idaho Avenue, NW. It is signed by more than 60 residents of Ward 3 who are members or guests at Temple Micah, a congregation located within ANC3C where the facility is sited.

Homelessness is a serious problem in the District, and Temple Micah strongly supports our city's effort to construct short-term housing for homeless families. The Ward 3 shelter must be able to accommodate 50 units for homeless families, which the signers understand drives the height and stories requirement. The signers do not believe this project will adversely affect the surrounding community. Without the proposed shelter at Ward 3, which supports a needed public objective, the District will not be able to meet its goal of closing the D.C. General family emergency shelter, and we will continue to lack housing for our homeless population. As such, we fully support the short-term family emergency shelter and hope that ANC 3C and the Board of Zoning Adjustment can support this project as well.
