Your application has been accepted as complete. You are hereby notified to appear before the Board of Zoning Adjustment (Board) on <u>Wednesday, March 1, 2017 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street N.W., Suite 220 South, Washington, D.C., 20001 for a public hearing concerning the following application:

Application of DC Department of General Services, pursuant to 11 DCMR Subtitle X, Chapters 9 and 10, for special exceptions under the parking requirements of Subtitle C § 703.1, and the RA-use requirements of Subtitle U § 420.1(f), and variances from the number of primary structure requirements of Subtitle C § 302.2, the loading requirements of Subtitle C § 901.1, and the height and number of stories requirements of Subtitle F § 303.1, to allow the construction of a six-story short-term family housing facility in the RA-1 Zone at premises 3320 Idaho Avenue N.W. (Square 1818, Lot 849).

- Notice of the hearing: A large orange placard sign featuring the case description must be posted and maintained on the subject property for at least <u>15 days</u> prior to the public hearing. <u>Obtain this sign at the Office of Zoning (OZ)</u>. Please call OZ at 202-727-6311 in advance to ensure that the sign is ready when you come in to pick it up.

- Affidavit of Posting: An Affidavit of Posting (Form 145) must be filed at least <u>5 days</u> prior to the hearing.
- Agent authorization: If not already filed, a signed letter of authorization citing Subtitle Y § 300.5 must be submitted by the Applicant if represented by an agent, including a licensed architect or attorney. Visit <a href="http://dcoz.dc.gov/resources/Letter of Agent Authorization/index.shtm">http://dcoz.dc.gov/resources/Letter of Agent Authorization/index.shtm</a> if you wish to be represented by a third party.
- Changes to application: In the event that the zoning relief requested changes prior to the hearing, a revised Self-Certification (Form 135) or a revised Zoning Deficiency Letter from the Zoning Administrator must be filed, as well as any additional filing fees that may apply.

#### Failure to submit required documents and additional fees could delay the hearing of your case.

### **INTERACTIVE ZONING INFORMATION SYSTEM (IZIS)**

In order to access and file documents for this case, log-in to IZIS at <u>https://app.dcoz.dc.gov/Login.aspx</u>. All documents provided must be submitted through IZIS at least <u>21 days</u> prior to the hearing (except for the Affidavit of Posting which must be submitted at least <u>five days</u> prior to the hearing). If you submit documents less than 21 days before the public hearing (or within five days in the case of the Affidavit of Posting), you must file a Motion to Request Waiver of Time Requirements (Form 150) in addition to the documents for consideration by the Board.

Letters and other documents may be filed by individuals and organizations in support of or in opposition to your application. Review the file in your application frequently so that you are prepared to respond to any issues that may be raised regarding your case. Note that the Board expects Applicants to make a good faith effort to reach out to those in opposition to resolve conflicts prior to the public hearing date.
