Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, March 1, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4<sup>th</sup> Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

**Application of DC Department of General Services**, pursuant to 11 DCMR Subtitle X, Chapters 9 and 10, for special exceptions under the parking requirements of Subtitle C § 703.1, and the RA-use requirements of Subtitle U § 420.1(f), and variances from the number of primary structure requirements of Subtitle C § 302.2, the loading requirements of Subtitle C § 901.1, and the height and number of stories requirements of Subtitle F § 303.1, to allow the construction of a six-story short-term family housing facility in the RA-1 Zone at premises 3320 Idaho Avenue N.W. (Square 1818, Lot 849).

**WHY YOU ARE RECEIVING THIS NOTICE**

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

**HOW TO FAMILIARIZE YOURSELF WITH THE CASE**

In order to review exhibits in the case, follow these steps:
