Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, March 1, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of the District of Columbia, pursuant to 11 DCMR Subtitle X, Chapters 9 and 10, for special exceptions under the parking requirements of Subtitle C § 703.1, and the RF-use requirements of Subtitle U § 320.1(a), and a variance from the height requirements of Subtitle E § 303.1, to allow the construction of a short-term family housing facility with a ground-floor health care facility in the RF-1 Zone at premises 850 Delaware Avenue S.W. (Square 590E, Lot 800).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case.
