Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on <u>Wednesday, March 1, 2017 at 9:30 am</u>, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of DC Department of General Services, pursuant to 11 DCMR Subtitle X, Chapters 9 and 10, for a special exception under the MU-use requirements of Subtitle U § 513.1(b)(6), and variances from the parking requirements of Subtitle C § 701.5, the loading requirements of Subtitle C § 901.1, the open court requirements of Subtitle G § 202.1, the height requirements of Subtitle G § 403.1, the lot occupancy requirements of Subtitle G § 404.1, and the rear yard requirements of Subtitle G § 405.2, to allow the addition to an existing building and operate a short-term family housing facility in the MU-4 Zone at premises 1700 Rhode Island Avenue N.E. (Square 4134, Lot 800).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:
