An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on March 26, 2017 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, June 7, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Eric Petersen, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception from the accessory building use requirements of Subtitle U § 301.1(e), to construct a two-story accessory dwelling to be used as a garage with a second-story dwelling unit in the RF-1 Zone at premises 1109 D Street, S.E. (Square 992, Lot 65).
