Application of David Hunter Smith, pursuant to 11 DCMR Subtitle Y § 704, for a modification of significance to the relief approved by BZA Order No. 19521 to include a variance from the accessory building requirements of Subtitle D § 1209.4, to construct a second story accessory apartment above an existing garage in the R-20 Zone at premises 3520 S Street N.W. (Square 1303, Lot 29).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
