## D.C. DEPARTMENT OF CONSUMER AND REGULATORY AFFAIRS' PARTIAL CONSENT MOTION TO STAY DEADLINE TO FILE AGENCY'S PRE-HEARING STATEMENT UNTIL RESOLUTION OF PENDING MOTIONS

The D.C. Department of Consumer and Regulatory Affairs (DCRA) respectfully submits this partial consent motion to stay the deadline to file DCRA's Pre-Hearing Statement until the Board has issued a decision on the following motions: (1) DCRA's Partial Consent Motion to Continue Hearing Until May 23, 2018; and (2) DCRA's Partial Consent Motion to Incorporate By Reference the Revised Permit Into This Appeal filed on April 20, 2018. In support of its motion, DCRA states as follows:

On March 31, 2017, DCRA issued Building Permit B1706219 (Permit). On May 30, 2017, this appeal from the issuance of the Permit was filed by the Appellant. On April 13, 2018, DCRA's attorney of record in this appeal, Maximilian Tondro, left DCRA and the undersigned attorney was appointed to represent the Agency in this appeal. DCRA issued a revised permit Building Permit B1805207 (Revised Permit) on April 18, 2018. Following the appointment of new DCRA counsel to this case, DCRA filed two motions: Partial Consent Motion to Continue Hearing Until May 23, 2018 and Partial Consent Motion to Incorporate By Reference the Revised Permit. In response, on April 26, 2018, the Appellant filed a "Memorandum In Opposition to the Motions of DCRA." The Board of Zoning Adjustment (Board) issued a Memorandum stating that the Board will address both of DCRA's motions during the public hearing scheduled for May 9, 2018.

In an effort to clarify the issues pending before the Board, DCRA submits that a thorough review of DCRA records shows that there is only one currently active building permit -B1706219 (the "Original Permit") - which has been revised by B1805207 (the "Revised Permit"). Per Section 105.3.8 of the Building Code,<sup>1</sup> the Revised Permit permanently amends the Original Permit so that only what is depicted on the approved plans for the Revised Permit is authorized to be constructed. Whatever changes the Revised Permit made to the Original Permit are final—the Permit Holder is not allowed to choose between the Original and Revised Permit. The Permit Holder may build <u>only</u> in accordance with the Revised Permit and approved plans associated with the Revised Permit, all of which are deemed to be part of the Original Permit per Section 105.3.8 of the Building Code.

In accordance with Title 11 Subtitle Y3 §302.17 of the Zoning Regulations, the Agency's Pre-Hearing Statement is due May 2, 2018. To conserve the parties' resources and in the interest of judicial economy, DCRA respectfully requests that the Board stay the deadline to file the Agency's Pre-Hearing Statement until resolution of the DCRA's pending motions. After the Board renders a decision on DCRA's pending motions, the Board should set a new date for filing DCRA's Pre-Hearing Statement. DCRA would be severely prejudiced if this Board does not grant this stay.

The Permit Holder consents to this continuance; the Appellant and the Intervenor do not consent.

For the foregoing reasons, DCRA respectfully, requests that the Board stay the deadline to file DCRA's Pre-Hearing Statement until the resolution of pending motions.
