Application of Tammika Thompson, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 320.2(l) from the residential conversion requirements of Subtitle U § 320.2(e), to convert an existing one-family dwelling into a three-unit apartment house with a rear addition in the RF-1 Zone at premises 428 Randolph Street N.W. (Square 3236, Lot 69).

#### WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.
