Application of Team Washington, Inc. d/b/a Domino's Pizza, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 513.1(c), and pursuant to Subtitle X, Chapter 10, for a variance from the use conditions of Subtitle U § 513.1(c)(1), to establish a fast food and food delivery establishment in the MU-27 and R-13 zones at premises 2330 Wisconsin Avenue N.W. WHY YOU ARE RECEIVING THIS NOTICE
