An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on September 5, 2017 through the Interactive Zoning Information System (IZIS).

A public hearing has been scheduled by the Board of Zoning Adjustment (Board) on **Wednesday, December 6, 2017 at 9:30 am**, at the Jerrily R. **Application of Fort Lincoln Retail LLC**, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle U § 513.1(n) from the use requirements of Subtitle U § 513, to permit a fast food restaurant with a drive-thru in the MU-5A Zone at premises Fort Lincoln Drive N.E. (Square 4327, Lot 1161).
