An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on September 8, 2017 through the Interactive Zoning Information System (IZIS).

Application of Leila Adler, pursuant to 11 DCMR Subtitle X, Chapter 9, for a special exception under Subtitle E § 5201 from the rear yard requirements of Subtitle E § 5004.1, to permit an existing rear garage in the RF-1 Zone at premises 1829 L Street N.E. (Square 4474, Lot 117).

You will need to create a username and password if you have not done so already.
