An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on September 8, 2017 through the Interactive Zoning Information System (IZIS).

Application of Timothy and Charlotte Lawrence, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5204 from the rear yard requirements of Subtitle E § 5104.1, and the side yard requirements of Subtitle E § 5105.1, and pursuant to Subtitle X, Chapter 10, for variances from the alley centerline setback requirements of Subtitle E § 5106.1, and from pervious surface requirements of Subtitle E § 5107.1, to construct a one-family dwelling on an alley lot in the RF-1 zone at premises 1665 Harvard Street N.W. (Rear). (Square 2588, Lot 827).
