Notice is hereby given that the Board of Zoning Adjustment (Board) will hold a public hearing on **Wednesday, December 6, 2017 at 9:30 am**, at the Jerrily R. Kress Memorial Hearing Room, One Judiciary Square, at 441 4th Street, N.W., Suite 220 South, Washington, D.C., 20001, concerning the following application:

Application of Timothy and Charlotte Lawrence, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions under Subtitle E § 5204 from the rear yard requirements of Subtitle E § 5104.1, and the side yard requirements of Subtitle E § 5105.1, and pursuant to Subtitle X, Chapter 10, for variances from the alley centerline setback requirements of Subtitle E § 5106.1, and from pervious surface requirements of Subtitle E § 5107.1, to construct a one-family dwelling on an alley lot in the RF-1 zone at premises 1665 Harvard Street N.W. (Rear). (Square 2588, Lot 827).

WHY YOU ARE RECEIVING THIS NOTICE

An Applicant in your neighborhood is seeking zoning relief for a project or use that is not allowed as a matter of right for the zoning district. The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.

HOW TO FAMILIARIZE YOURSELF WITH THE CASE

In order to review exhibits in the case, follow these steps:

- Visit the Office of Zoning (OZ) website at <http://dcoz.dc.gov>
- Under “Services”, click on “Interactive Zoning Information System”.

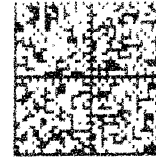

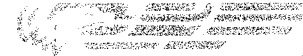
