An Applicant within the boundaries of your ward is seeking zoning relief for a project or use that is not provided as a matter of right for the zoning district. This application was filed on September 20, 2017 through the Interactive Zoning Information System (IZIS).

Application of HJB Properties, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions from the residential building conversion requirements of Subtitle U § 320.2, and from the building height requirements of Subtitle E § 5203.1 to construct a rear addition to an existing one-family dwelling and convert it to a three-unit apartment house in the RF-1 Zone at premises 1121 Morse Street N.E. (Square 4070, Lot 138).
