Application of HJB Properties, LLC, pursuant to 11 DCMR Subtitle X, Chapter 9, for special exceptions from the residential building conversion requirements of Subtitle U § 320.2, and from the building height requirements of Subtitle E § 5203.1 to construct a rear addition to an existing one-family dwelling and convert it to a three-unit apartment house in the RF-1 Zone at premises 1121 Morse Street N.E. WHY YOU ARE RECEIVING THIS NOTICE

The Zoning Regulations of the District of Columbia (Regulations) require such applicants to appear before the Board at a public hearing to make their case. The Regulations also require that notification of the public hearing be provided to property owners within 200 feet of the subject property indicated in the application, based on DC Office of Tax and Revenue records.


